



3. That the Objects for which this trust is established are:





- 5. All the incomes, earnings, movable/immovable properties of the trust shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the trust or to any person claiming through any one or more of the present or the past members. No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.
- 6. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time.
- 7. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
- 8. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.

 If the trust needs to be dissolved it shall be dissolved as per provision laid down under section 13 & 14 of the Indian Trust Act 1882.
- Subject to the Provisions of Income Tax Act. 1961 as amended from time to time, Trustees will keep the Trust fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or construction of any immovable property including acquisition or mortgage by way of fresh charge buildings and/or in the purchase and on any immovable property in India, of free-hold or lease-hold tenure, and may deposit scheduled Bank, Company or Private firm or Individual on the amounts with any such terms and conditions as they think fit, In the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and provision including all the posers contained by and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of take in effect.

(ii) To apply the whole or any part of the income of the Trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the

trustees may, in their discretion, deem fit from time to time.

(iii) To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

(iv) To adjust, settle, compromise, compound refers to arbitration, all actions. Suits

claims, demands and proceedings regarding the Trust Fund.

(v) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

(vi) To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and/or running any institution in furtherance of the objects of the Trust and otherwise

for giving effect to the objects of the Trust.

(vii) To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.

(viii) To set apart and/or allocate the whole or a part of the income or the corpus of

the Trust Fund or part thereof for any of the objects of the Trust.

(ix) To join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

(x) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereinafter be established for the like charitable purposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start maintain, or carry out such charitable objects.

(xi) To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.

(xii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

(xiii) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters

- within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- (xiv) To take over or amalgamate with any other charitable trust, trustee, association, or institution with similar objects.
- (xv) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (xvi) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
- 11. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
- The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
- 13. The managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.
- 14. A person shall cease to be a Trustee either:
 - If he without leave of absence does not attend three consecutive meetings of the -Trustees or for one calendar year, whichever is longer, or
 - If he is requested to resign by 3/4th or as near thereto as possible of the remaining trustees.
- 15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.

The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:

- (a) Three trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided by 3/4th majority by the Trustees.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of 3/4th of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- 16. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
- 17. The accounting year of the Trust shall be the financial year ending on 31ST March every year.
- 18. The Trust and the Trust funds shall be irrevocable for all the times.
- 19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly

20. POWER & FUNCTION OF THE OFFICE BEARER

SETTLER: (Abhimanu Kumar, President)

The President shall preside at all meetings of the Managing Trustee and of the trust, when he is present and shall exercise such other powers as are conferred upon him by these rules. The President may call for an emergency meeting through President Signed notice in a shorter notice. The decision of President that a resolution has been carried or lost shall be conclusive, unless such a decision is challenged and a poll is demanded; on poll being demanded, the same shall be taken in such manner as the President may in discretion determine. In case of a tie the President shall have a second or casting vote.

a) He shall be convener of all the meetings and without his signature on the notice of meetings no meetings will be valid.

b) It shall be his duty to see that the resolution at the respective meeting are implemented and give to effect too timely.

c) In the absence of Secretary, the President will look after all powers conferred on Secretary.

d) President shall appoint, suspend, discharge, fix the salary, make payment of the employees of the institution and conducted by the trustee on behalf of the Managing Trustee.

TRUSTEE: (Manoj Kumar, Secretary)






