**3. That the Objects for which this trust is established are:**

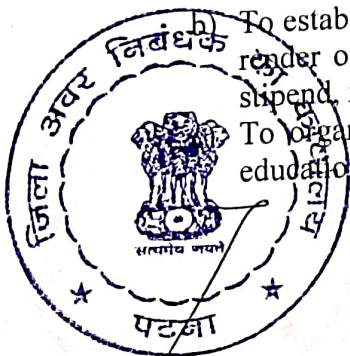
- [A.] The organization will run Education field.

4. All the activities shall be Non Profitable and shall be done on 'No Profit-No Loss' basis.
5. All the incomes, earnings, ~~movable/immovable properties of the trust~~ shall be solely utilized and applied towards the promotion of its Aims and Objects only as set forth in the deed of the trust and no profit thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any manner whatsoever to the present or the past member of the trust or to any person claiming through any one or more of the present or the past members. ~~No members of the trust shall have any personal claim on any movable or immovable properties of the trust or make any profits, whatsoever, by virtue of his membership.~~
6. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contribution from time to time.
7. That the Trust Fund shall not be applied for any purpose other than those specified in Para 3 herein above unless the other objects added to the trust objectives.
8. That the Trustees shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust. If the trust needs to be dissolved it shall be dissolved as per provision laid down under section 13 & 14 of the Indian Trust Act 1882.
9. Subject to the Provisions of Income Tax Act. 1961 as amended from time to time, the Trustees will keep the Trust fund or such portion thereof, as they may, in their absolute discretion, think fit and proper, without being answerable or accountable to the beneficiaries or any other party for any loss invested in such shares, stock, securities and debentures of acquisition or construction of any immovable property including buildings and/or in the purchase and acquisition or mortgage by way of fresh charge on any immovable property in India, of free-hold or lease-hold tenure, and may deposit the amounts with any scheduled Bank, Company or Private firm or Individual on such terms and conditions as they think fit, In the matter of investment of Trust funds, the provisions of section 20 of the Indian Trust Act shall apply; in the event of Trustees purchasing any immovable property or properties or advancing moneys or mortgage, they shall be entitled to accept such title or evidence of title as they shall think fit in their absolute and uncontrolled discretion. The Trustees shall have power, if any deed it in their absolute discretion to sell the Trust Fund or any part thereof and any such immovable property purchased by them under the power aforesaid and any other shares, securities, etc. and stand possessed of the money to arise from such sale upon after paying there out the expenses pertaining to such sale upon the Trusts and with the subject to powers and provision including all the posers contained by and under these presents declared and contained concerning the Trust Fund which or the proceeds thereof, shall have laid out in purchase of property or properties as have laid out in purchase of property or properties as aforesaid or such of them as shall be then subsisting and capable of take in effect.

- (i) To accept any donation, contribution grant or subscription in cash or in kind, from any person(s) body of persons or trust or body corporate with or without conditions.
- (ii) To apply the whole or any part of the income of the Trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- (iii) To open account in the name of the Trust, with a Bank or Banks, to operate such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.
- (iv) To adjust, settle, compromise, compound refers to arbitration, all actions. Suits claims, demands and proceedings regarding the Trust Fund.
- (v) To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or managing Trustees or otherwise) for the purpose of the administration of the Trust in such manner and subject to such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.

- (xi) To settle all accounts and to compromise, abandon, or refer to arbitration any action or proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.
- (xii) To borrow money either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purposes of these presents, and it shall be lawful for the Trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (xiii) To apply to the Government, public bodies, urban, local municipal, district and other bodies, corporation, companies, or persons for and to accept grant of money and of aid, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to discuss and negotiate with the Government Departments, public and other bodies corporations, companies or persons, scheme and other work and matters

- within the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- (xiv) To take over or amalgamate with any other charitable trust, trustee, association, or institution with similar objects.
- (xv) To take over, acquire, manage, control or aid any existing institution or institutions having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.
- (xvi) To purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities and engagement of any or more of the trusts, societies, institutions or associations with which this Trust is authorized to amalgamate.
11. The Trustees shall be accountable only for such money, and funds, which will actually come into their hands.
12. The Trustees will not be entitled to receive any remuneration, but the Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
13. The managing Trustee for the time being will be at liberty to appoint additional Trustee within the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.
14. A person shall cease to be a Trustee either:
- If he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or
  - If he is requested to resign by 3/4<sup>th</sup> or as near thereto as possible of the remaining trustees.
15. Every Trustee will be at liberty to resign on giving one month's notice of his intention to do so.
- The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations:
- (a) Three trustees shall form a quorum for a meeting of the Trustees.
- (b) All matters will be decided by 3/4<sup>th</sup> majority by the Trustees.
- (c) Resolution passed without any meeting of the Trustees but by circulation thereof and evidenced in writing under the hands of 3/4<sup>th</sup> of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
16. The Trustees shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoing ought to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
17. The accounting year of the Trust shall be the financial year ending on 31<sup>ST</sup> March every year.
18. The Trust and the Trust funds shall be irrevocable for all the times.
19. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions hereof shall be construed accordingly.

## 20. POWER & FUNCTION OF THE OFFICE BEARER

### SETTLER: (Abhimanu Kumar, President)

### TRUSTEE: (Manoj Kumar, Secretary)

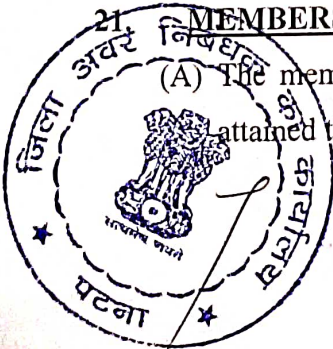
- He shall be in charge of the office and shall be responsible to general body in all matters. He will contract in all ways and means of the position of the association and shall have right to improve it.


